MINUTE APPROVAL:

Minutes of the February 2, 2015 Re-Organization and Regular Meeting were presented for approval. A Motion was offered by Mrs. Feulner, seconded by Mr. Schaffer and approved with all Members present voting in the affirmative to accept the February 2, 2015 Minutes as presented. The Motion passed.

OLD BUSINESS:

No Old Business was discussed.

NEW BUSINESS:

Mr. Higgins was asked to provide the Report of Audit for 2014. Mr. Higgins summarized the audit findings and concluded his report by stating the RSA received no audit recommendations. Some discussion took place regarding charges of line item AE/OE operating expenses from prior years. In addition, discussion took place regarding the Rate Hearing scheduled for June 1, 2015; specifically the calculation of a per unit charge. At the conclusion of that discussion and without further comments as to the audit report for 2014, a motion was offered by Mr. Schaffer, seconded by Mr. Cumiskey to accept RSA Resolution 2015-5 regarding Certification of the Annual Audit.

WHEREAS, the Local Finance Board has promulgated N.J.A.C. 5:30-6.5, a regulation

Authority no later than forty-five days after the receipt of the annual audit, pursuant to
N.J.A.C. 5:30-6.5; and
WHEREAS, all members of the Authority have received and have familiarized
themselves with, at least the minimum requirements of the Local Finance Board of the
State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as
provided by the Local Finance Board; and
WHEREAS, failure to comply with the regulations of the Local Finance Board of the Stat
of New Jersey may subject members of the local Authority to the penalty provisions of
R.S. 52:27BB-52, to wit:
R.S. 52:27BB-52: A local officer or member of a local Authority who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of
fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a
misdemeanor and, upon conviction, may be fined not more than one thousand
dollars (\$1,000.00) or imprisoned for not — more than one year, or both, and in
addition shall forfeit his office.
