## MINUTES OF A REGULAR MEETING OF THE ROCKLEIGH SEWERAGE AUTHORITY HELD AT BOROUGH HALL 26 ROCKLEIGH ROAD, ROCKLEIGH, NEW JERSEY JULY 12, 2021 AT 7:30 PM

Mr. Pontone called the meeting to order and following the Pledge of Allegiance, the Opening Statement was read. MINUTES: Minutes dated December 7, 2020 and February 1, 2021 were both tabled due to lack of voting eligible quorum. These Minutes will both be presented at the October 4, 2021 quarterly meeting.

**NEW BUSINESS**: Mr. Higgins provided a synopsis of the Audit Report for 2020. At this time Mr. Higgins reviewed the RSA 2021 Sewer Rate Study with the Members. Mr. Higgins reported that the sewer rate has stayed pretty even from last year. The Bergen County schools were down in usage due to their closures two years ago. A Motion was offered by Mr. Schaffer, seconded by Mr. Pontone to open the meeting to the public as to the 2021 Rate Study for its public hearing. All Members voted in the affirmative. The Motion passed. Mr. Regan noted for the record that no public was present for this hearing. Motion offered by Mr. Schaffer, seconded by Mr. Pontone to close the meeting to the public as to the 2021 Sewer Rate hearing. All Members present voted in the affirmative. The Motion passed. At this time Mr. Pontone made a motion to adopt the 2021 Sewer Rate Study as prepared by Lerch, Vinci and Higgins.
